1. What is a cookie?

Cookies are small text files or pieces of information that are stored on your computer or mobile device (such as a smartphone or tablet) when you visit our Digital media. A cookie will usually contain the name of the Digital media/application from which the cookie has come from, the duration of the cookie (i.e. how long the cookie will remain on your device), and a value, which is usually a randomly generated unique number.

2. Why do we use cookies?

• Persistent cookies are used to save your login information and remember your settings for future logins to our Digital media. A persistent cookie is a cookie stored as a file on your computer, and it remains there when you close your web browser. The cookie can be read by the Digital media that created it when you visit it again.

- Session ID cookies are used to enable certain features of our Digital media and services, to better understand how you interact with our Digital media and to monitor aggregate usage and web traffic routing. Unlike persistent cookies, session cookies are deleted from your computer when you close your browser. They usually store an anonymous session identifier on your computer allowing you to browse a digital media / application (for example) without having to log in to each page.

b) Analytics cookies
